President Leakas suspended the meeting at 8:05 P.M. for refreshments; all Board of Education members were in favor. The meeting resumed in the Media Center at 8:15 P.M.

VI. Superintendent's Report Dr. Zoeller reported on the following:

- There are a number of workshops/conference requests being approved this evening.
- The board will be approving the baseball/softball schedule.
- A number of field trips will be approved tonight, including several to the Township library.
- Kindergarten registration is ongoing for next year Mr. Cannici will talk about that in more detail.
- The 2016-2017 school calendar will be approved tonight along with a revised calendar for this year. To date we have not used any of our snow days, therefore the end of the school year will be moved up to June 21<sup>st.</sup> The other two days will be taken on the Friday/Tuesday of Memorial Day weekend. If a snow day/emergency day is needed between now and Memorial Day, we will use those two days to cover.
- We have a number of policies up for a final reading and adoption, two revised policies, job description change.
- Finally, we will approve the district's Comprehensive Equity Plan, thank you to Mr. Cannici and his committee for putting together the Comprehensive Equity Plan.

## VII. Director of Curriculum & Instruction's Report Mrs. Hurd reported on the following:

- Curriculum update- Mrs. Hurd met with the ELA teachers discussed creating a core group of teachers to discuss the current curriculum and the direction in which she would like to go when writing the ELA curriculum next year. Mrs. Hurd would like to have brain storming sessions which include teachers from Maywood, and Hackensack. Curriculum writing will take a break during the upcoming testing period.
- PARCC/NJASK the testing schedule has been posted on the website. Mrs. Hurd mapped out what testing will take place.
- Mrs. Hurd met with the Rochelle Park Library Director, Julia Perrotta. Their goal was to discuss ways to increase the communication between the RP Library and Midland School. The novels and educational resources the teachers and students use here at Midland throughout the year were shared with Ms. Perrotta. Ms. Perrotta is interested in purchasing some of those materials to have them available for the students. Also with assistance from Mr. Cannici, trips to the library were arranged. They will keep in touch regarding summer reading lists to ensure that extra copies of books are available to our students.

#### VIII. Principal's Report Mr. Cannici reported the following:

- Mr. Cannici acknowledged the presences of Mr. Grossman's students and welcomed them to the meeting.
- Today the district hosted students from Hackensack High School as part of the "Careers in Education Day." Students observed various teachers and grade levels to give them exposure to the field of education. The program headed by Dr. Tara Jakubik, is a former student of Midland School who is now teaches at Hackensack High School in addition to coaching at the high school. Mr. Cannici is proud to say that this is the second year the school has participated in the program, it is a great success.
- Mr. Cannici touched on the trips to the Library that the grades 3-5 will be taking. It is a great opportunity to visit the facilities and learn about the programs and resources that are available to them.
- Midland School is again participating in the Leukemia & Lymphoma Society's (LLS)
  Pennies for patients program. A service learning program that gives students the unique
  experience of working together to help raise awareness and funds in honor of thousands
  of children and adults fighting against blood cancers. He hopes to raise a lot of funds for
  this program.

Mrs. Leakas welcomed Mr. Grossman's 8<sup>th</sup> grade students.

Mrs. Pardo- W. Oldis St. On the curriculum guides posted on line, she's not seeing separate curriculums for regular and advanced language arts.

Mrs. Hurd responded that the curriculums are not different. Advanced uses different books, content is the same, but higher order level thinking.

Mr. Trawinski- Forest Pl. Asked for an explanation of F13, and which room that it pertains to

Dr. Zoeller explained the temporary waiver is for one period, once a week where the number of students exceeds the allotted amount, by one student. Could have taken out the bookcases, which would have given us the allotted square footage in the media center.

Mr. Trawinski reiterated one student, and asked if the 6<sup>th</sup> grade students, will they be getting textbooks this year for science.

Dr. Zoeller stated no, the instructor will be using what she has, nothing has gone missing, Due to the state changing the standards, and the district not knowing what direction the state will be going in.

Mrs. Hurd interjected that it's not just Rochelle Park there are no textbooks that are aligned to the new standards, added that she has researched textbooks, as well as reached out to the different textbook companies. In the meantime samples have been ordered that can be utilized along with online resources.

Mr. Seymour Marinus St. Expressed concerns over the one student over the max occupancy limit, asked how that was established. Are you certain it's only one student?

Dr. Zoeller explained that the district knows how many students are in the room, plans were sent to the state, smaller tables were ordered. Plans were reviewed by the Department of Education, Executive County Business Administrator. If the bookcases and cabinets were removed we would be ok but that throws off the footage. Lost free available footage, due to the additional furniture the teacher brought with her.

Mr. Seymour clarified, either we get a waiver or pull the stuff out. Was the teacher involved, other solutions?

Dr. Zoeller explained that the schedule cannot accommodate it. There are only 2 sections, the student moved into the district in January to redo the entire schedule impacts everything else, music, art, PE, speech therapy etc. Impacts so many other things, not a feasible alternative. It's one period out of the 45 in a week and that would be chaos for everyone else. Mr. Seymour asked if we get a waiver what impact does that have on the ability of students to learn. Looked at the plans of the room at the town hall, he believes with the long table's kids can't see the smart board. In his option, 5 to 7 kids who can't participate in instruction. There should be other solutions to getting these kids to see the smartboard, look at the plans, any way more than 26 kids can get instruction. He calculates the room is max 5 over and questions if we are in compliance. What about the students that can't see the smartboard. He feels there should be some collaboration between Mrs. Hurd and the teacher, addressing her concerns.

**WHEREAS**, the Board of Education of the Borough of Rochelle Park in the County of Bergen, New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed thereby) has, pursuant to N.J.S.A. 18A:18A-4.6, (the "ESP Law"), determined to undertake an energy savings plan; and

**WHEREAS**, Concord Engineering, on behalf of the Board, has developed an ESP based upon a scope of projects including individual energy conservation measures ('ECM's") and including annual energy and operational savings and a proposed cash flow pro forma (the "ESP"); and

**WHEREAS**, in accordance with the ESP Law, the Board appointed CHA Companies, Inc. to act as a "third party verifier" in order to verify the savings set forth in the ESP; and

WHEREAS, CHA Companies, Inc. has verified the savings set forth in the ESP; and

**WHEREAS**, the ESP, as verified, has been submitted to and approved by the New Jersey Board of Public Utilities; and

**WHEREAS**, the Board has determined that the energy savings generated from ESP will be sufficient to cover the cost of the program's ECM's set forth in the ESP, and, therefore, has determined to implement the ESP pursuant to N.J.S.A. 18A:18A-4.6 et seq. and to finance the ESP thorough the issuance of energy savings obligations authorized as a lease purchase agreement pursuant to N.J.S.A. 18A:18A-4.6(c); and

**WHEREAS**, in order to continue to move the ESP forward, the Board seeks to (i) approve and adopt the ESP; (ii) authorize the bidding/installation of the ESP in accordance with the ESP Law; and (ii) authorize the seeking of bids and the award thereof for the lease purchase financing of the ECM's and other costs of the ESP.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF ROCHELLE PARK IN THE COUNTY OF BERGEN, NEW JERSEY AS FOLLOWS:

 $\pmb{\text{SECTION 1.}}$  The Board hereby approves and adopts the ESP as submitted to and approved by the BPU.

**SECTION 2**. The Board hereby authorizes the bidding and installation of the ESP.

**SECTION 3.** The Board hereby authorizes and directs the distribution of a request for bids for a lease purchase agreement in an amount not to exceed \$250,000 to finance the improvements set forth in the ESP. Phoenix Advisors, LLC and Wilentz, Goldman & Spitzer, P.A., are hereby authorized to draft and distribute such request for bids. The Business Administrator/Board Secretary is hereby authorized award the lease purchase agreement upon the advice of Phoenix Advisors, LLC. The Board hereby authorizes (i) the execution and the delivery of the Lease and other related documents, including an Escrow Agreement, and (ii) the performance by the Board of its obligations under the Lease and the Escrow Agreement, both to be dated the date of closing. The Board further authorizes and directs the Board President (or in every instance where the Board President is authorized to execute a document under this Resolution the same such authority shall also be given to the Vice President), and the School Business Administrator/ Board Secretary to approve any non-material changes, additions or deletions to the Lease and the Escrow Agreement as may be necessary in the judgment of the Board's Bond Counsel. The Lease sets forth, among other things, the lease payments of the Board and their respective amounts. In all respects, the Lease shall be consistent with the terms of this Resolution. The Board President and the School Business Administrator/ Board Secretary are hereby authorized and directed to execute and to deliver on behalf of the Board each of the agreements referred to in this Resolution and such other agreements and certificates as may be necessary to complete the transaction contemplated by the Lease and the Board President and School Business Administrator/ Board Secretary are hereby authorized and directed to take, on behalf of the Board, such other actions as shall be necessary and appropriate to accomplish the lease purchase financing of the ESP in accordance with the terms of the Lease and this Resolution and pursuant to the terms of the agreements and the instruments authorized to be prepared hereby and to accomplish the performance of the obligations of the Board in respect thereof.

**SECTION 4.** The Board hereby covenants that it will comply with any conditions subsequently imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of interest on the Lease, including, if necessary, the requirement to rebate all net investment earnings on the gross proceeds above the yield on the Lease.

**SECTION 5**. The Board reasonably expects to reimburse its expenditure of ESP Costs paid prior to the issuance of the Lease with proceeds of the Lease. This resolution is intended to be and hereby is a declaration of the Board's official intent to reimburse the expenditure of ESP Costs paid prior to the issuance of the Lease with the proceeds of the Lease, in accordance with Treasury Regulations §150-2. The maximum principal amount of the Lease expected to be issued to finance the ESP is \$250,000. The ESP Costs to be reimbursed with the proceeds of the Lease will be "capital expenditures" in accordance with the meaning of Section 150 of the Code. No reimbursement allocation will employ an "abusive arbitrage device" under Treasury Regulations §1.148-10 to avoid the arbitrage restrictions or to avoid the

restrictions under Sections 142 through 147, inclusive, of the Code. The proceeds of the Lease used to reimburse the Board for ESP Costs, or funds corresponding to such amounts, will not be used in a manner that results in the creation of "replacement proceeds", including "sinking funds", "pledged funds" or funds subject to a "negative pledge" (as such terms are defined in Treasury Regulations §1.148-1), of the Lease or another issue of debt obligations of the Board, other than amounts deposited into a "bona fide debt service fund" (as defined in Treasury Regulations §1.148-1). All reimbursement allocations will occur not later than 18 months after the later of (i) the date the expenditure from a source other than the Lease is paid, or (ii) the date the ESP is "placed in service" (within the meaning of Treasury Regulations §1.150-2) or abandoned, but in no event more than 3 years after the expenditure is paid.
