## III. Open Public Meetings Act, Chapter 231, P. L. 1975 Announcement – by Board President

In accordance with the requirements of the Open Public Meetings Act, I wish to announce that:

#### IV. Dr. Geoffrey W. Zoeller, Jr. / Mrs. Jennifer Pfohl

#### • Presentation of the Proposed 2016-2017 Budget

Dr. Zoeller opened by thanking the Board of Education members for their time and effort put into this budget development. Highlights of the PowerPoint showed that the total budget for next year is actually going down by -3.68%, however, residents will see an increase in taxes for the budget of approximately \$9.00 a month for the 2016/2017 budget on a home assessed at \$334,000.00. That number should be a negative since the budget went down, and what happened is that Rochelle Park's local tax base decreased by \$13 million. Therefore fewer taxpayers to spread out the amount, makes less people pay more. There will also be a decrease of

\$22.52 for the average home valued at \$334,000, for the referendum compared to last year.

## • Board Discussion on Proposed Budget

Mrs. Judge Cravello stated that the town budget went down by \$6.00. How did they do it?

Mrs. Pfohl replied that it depends on their budget (which she has not seen) Could be (and she is speculating- since she hasn't see it) that it could have been a recent contact negotiation or some other agreement that changed. Mrs. Pfohl explained that the numbers are based on the most recent figures she could obtain; they are subject to change and may before next fall.

Dr. Zoeller added that the municipality might have used surplus.

Mrs. Judge Cravello asked where the figures came from.

Mrs. Pfohl replied the county, and she confirmed them with the town.

Dr. Zoeller added that about 3 or 4 years ago the township made an extra tax payment to the school. The school accountants picked it up and the school cut a check back to the township. They may have used that money. How it was not caught by the township is unknown, but when it became known to the district we immediately returned it.

Dr. Zoeller stated students that come from somewhere else to be educated here.

Mrs. Pfohl explained that they were the pre-school paid tuition students. The district doesn't get state aid for them.

Dr. Zoeller explained that in the past they were not coded properly, not state aid eligible

Mrs. Verhasselt inquired about a statement Dr. Zoeller made during the presentation regarding benefits and the increased amount being set by the State of New Jersey. She asked doesn't each district determine the benefits for their employees.

Dr. Zoeller explained that under chapter 78 the district did not have that option. We are in year 4. Three years ago the contract was settled and the negotiations went with what the state had asked, but nothing more. The benefits it is referring to is heath care costs.

Mr. Trawinski Forest Pl.- inquired about the maintenance budget and it going up, he thought the referendum, energy audit that number would have went down not up.

Dr. Zoeller explained that there are still some items that need to be done that were not included in the referendum, for instance a fence around the playground area, some of our younger students like to bolt, and that is a safety concern. Things like that are in there.

Mr. Trawinski asked where he could see a breakdown of what was in that line item.

Mrs. Pfohl added that the public would likely be surprised by some of the items included in that line item, as dictated by the state. She told Mr. Trawinski she would be happy to go over it with him, emails were exchanged.
