- V. Superintendent's Report, Dr. Zoeller reported the following:

 - Slight changes to the calendar. School will be closed on January 2, 2017; this will extend the year by one day.
 - This is the annual personnel meeting. The motions reflect this year's salary and so forth, due to no settlement in the contract with the RPEA. Adjustments will be made when contact is settled.
- VI. Director of Curriculum & Instruction's Report, Mrs. Hurd reported the following:

- Middle School math met today, all three districts were in attendance. Good conversation regarding how to get these students ready for 9th Grade, will meet one more time and also over the summer.
- Music Curriculum one more meeting and then it will be complete.

The public is reminded that their remarks are being recorded.

The Board wishes to remind all attendees at its meetings that while it subscribes without reservation to the principle of keeping the community completely informed, it cannot respond to or discuss personnel matters. If a matter concerning a district staff member is of interest or concern to a resident, the matter should be referred to the Building Principal, Superintendent of Schools, or the Board of Education, either by telephone, letter, or email.

Each speaker's statement will be limited to five (5) minutes in duration. The Public Forum will be limited to one (1) hour in duration.

Mrs. Verhasselt- Forest Pl. Had two questions the one was addressing a rumor that students who can't afford trips- people were told school cannot help.

Dr.Zoeller assured Mrs. Verhasselt that every child will go on a trip. Operational funds cannot be used. The account the account was an interest based account and we no longer get interest for that account. Times are tough and we need to find a mechnasim to pay into it. Members of the board and administration have chipped in and no student would be denied. We make it work.

Mrs. Verhasselt second question was in regard to Dr. Zoeller's contract. She quoted a section on outside activities- short term duration she asked what does that mean. She was asking for classification of the language in Dr. Zoeller's contact. She proceeded to ask if his absences are recorded somewhere. It was clarified that his absences are kept in the same database that records all other employee absences. She feels it has to be board approval, and never saw it in the minutes.

Mr. Scully- asked board approval of what?

Mrs. Verhasselt read the passage from the contract; she believes that every instance needs approval by the board.

Dr. Zoeller explained that he cannot take long term engagements, take a professorship at a university, that type of thing. It's a boiler plate contact for the state of New Jersey.

Mrs. Verhasselt is asking about got more specific in regard to mentoring.

Dr. Zoeller explained he does mentor and that the Board is aware of it.

Mrs. Verhasselt asked if Dr. Zoeller has ever left prior to 2 P.M., if so, how often can this happen. *President Leakas explained that a Superintendent is not a standard* 8-4, *he is on call* 24/7, *and they have spoken at night, and on weekends*.

Mrs. Judge Cravello trying to understand the question, asked if Mrs. Verhasselt was questioning if he mentors on the schools' dime.

Dr. Zoeller interjected that he will get clarification for the next meeting.

Mrs. Giglio Garfield – read a statement regarding the integrity of Dr. Zoeller and Mr. Allos. She is disappointed by statement made at last month's meeting by Dr. Zoeller and Mr. Allos.

President Leakas thanked Mrs. Giglio for coming, asked if she was not at the meeting last month how would she know about the statements made? Mrs. Giglio confirmed that she has a copy of the recording of the previous meeting. President Leakas, believes the board has listened, the new computer room is (in her opinion) state of the art and much better than the old room. In the old room students faced a wall. It was not state of the art. Mrs. Leakas takes issue with the accusations of the Board.

Mrs. Giglio stated we would meet privately.

Mrs. Kondyra North Dr. quick question, she sees a number of classroom aides being approved. Asked if this is an increase in the number of aides the district currently has.

Dr. Zoeller explained that it is exactly the same.

Mrs. Kondyra feels that her son is not getting the in-class support that he needs. It is part of his IEP, and she has a copy of it.

Dr. Zoeller I cannot discuss confidential student matters in public, suggested Mrs. Kondyra contact her son's case manager, and if it's not solved then you should contact Mr. Cannici.

Mrs. Kondyra she is happy with the Special Education Department at Midland, however, she has asked even went to Mr. Cannici and was not satisfied with the outcome.

Dr. Zoeller added he was not aware of the situation. He will look into it.

Mr. Robert Stack- Leonia wanted to talk about the field trip, its state law that in the case of a hardship the district has to pay for that. It's not a slush fund; the board is obligated by state law.

Dr. Zoeller respectfully disagrees with Mr. Stack. He is not saying it is not the districts responsibility, but where does the money come from? We cannot take taxpayers dollars to pay for these students.

Mrs. Abraham interjected who said that we wouldn't pay for the students?

Dr.Zoeller added it is a long standing practice He has documentation going back to Dr. Schone and Dr. Oberkehr stating that the account had to be self-sustaining.

Dr. Zoeller will contact the board attorney and see if there is an alternative way at addressing this.

Mrs. Cravello were any students denied?

Mr. Stack stated he was told they could not go on the trip.

Dr. Zoeller questioned about the reimbursement from Liberty Science Center.

Mr. Stack stated he did not know that.

Mrs.Elaine Rainone Lincoln. Clarify the teachers have all chipped in for students who could not pay. In the past she would go to the Superintendent and the board and teaches' made it possible. They did not budget for hardships.

President Leakas suggested looking at the trips and trying to do trips that are more budget friendly Mr. Scully We cannot pay for field trips are there any other mechanisms. On an annual basis we do some type of fundraising or something

Dr.Zoeller: The board does not pay for trips, that is why we charge in the first place. He will look further into it.

Mrs. Maurer Patton Ct. It is law, includes yearbooks, cap and gowns, they should not pay and other parents should not have to pay for that.

Mr. Scully asked if there was anything we can do. Mrs. Maurer- in high school it was all payed for. Maybe Title II?

President Leakas asked for everyone to give respect when someone is speaking.

Dr. Zoeller the question is how do we do it and through what avenue.

Mrs. Maurer voiced her option that a child should not be sent home with a permission slip and embarrassed to go home and ask that question.

Mrs. Judge Cravello was trying to remember when she was on the board; we somehow came up with it. Don't remember ever denining a student.

Mrs. Maurer now there are a lot more students on free and reduced; it's the times. Mentioned the money that comes back from the photographer and also the book fair.

President Leakas the book fair is now under the PTA.

Dr. Zoeller: the picture money goes to the yearbook.

The discussion continued Dr. Zoeller will investigate as to how we might be able to better address this.can do this.

Mr. Hornes, Maywood: The money from Liberty Science Center. The school has the money, and I don't know where it went. He wanted to make it clear that he doesn't have it.

Mrs. Parto W. Oldis St why no separate and honors ELA curriculum guide on the website, there should be something concrete.

Mrs. Hurd, the ELA and Math met with her over last summer, the content is similar, and more advanced questions. We are in the process of doing ELA for next year.
