2018 School Year

Personnel/Negotiations Gerald Sorrentino – nothing to report

Business, Finance, and Transportation Teresa Judge Cravello – finances are good, budget will be sent over to the county.

Curriculum, Instruction, Assessment, and Technology Dimitria Leakas – all staff will be trained, the PARCC steering committee is meeting weekly. Media curriculum is currently being revised. Mrs. Leakas asked Dr. Zoeller to explain the Chrome book arrangement, he gladly explained it. *Mr. Kral thanked Dr. Zoeller and the administration for this initiative*. Mrs. Leakas thanked the teachers involved with the last Coffee with the Superintendent.
