III. Open Public Meetings Act, Chapter 231, P. L. 1975 Announcement – by Board President

IV. Joint Board Meeting with Township Council

• 9-11 Memorial- Mr. Valenzuela gave a presentation on the Memorial and artist renditions of the design were on hand. The New Jersey Port Authority made available pieces of steel to communities shortly after 9/11. The piece of steel that Rochelle Park received will be embedded into the monument. It will be similar to other monuments onsite. Revisions will be made to the surrounding landscape. Flags from each branch of the armed forces along, with Rochelle Park Police, Fire and Ambulance will be displayed. So far the committee has raised \$16, 500.00. The biggest donation came from Shop Rite/Glass Gardens for \$10,000.00. The committee is still accepting donations and can be contacted through the Town Hall.

President Bilka asked if any work would be done to the other monuments and would the existing flagpole remain.

Mr. Davidson stated the flagpole remains.

Mr. Valenzuela stated that other work will be done in the area.

Mrs. Lauerman asked about the funding and can outside people solicit funds or only the committee. Is it still on going?

Mr. Valenzuela stated that funds are still being solicited; hopefully a trust fund can be set up to maintain the area.

Mr. Davidson stated he would get a solicitation letter to Mrs. Lauerman. Any private donations can be made payable to the 9/11 Memorial Trust Fund and be dropped off at the Town Hall.

Mr. Esposito commented on the drawings, stating they were much nicer than the original draft proposed.

Mr. Ammerman stated he was pleased to have the joint board meeting and commented that it was nice to have something involving both the town and school together. At this time he also thanked the DPW for their help with the fields. He introduced Ms. O'Brien and Mrs. Leakas who gave a presentation on a proposed 5K Run/Walk.

• **Proposed 5-K Run Sept 2013-** Ms. O'Brien gave a power point presentation on the proposed 5K Run/Walk. The presentation consisted of two location proposals. One running through the county park and the other through the streets in Rochelle Park. It addressed the costs associated with each area. Some will remain the same for both locations, while other costs differ depending on location.

President Bilka- inquired about the insurance liability.

Ms. O'Brien stated the school district and the township would have to carry a rider for the day.

Mayor Scarpa stated the township rider would not be a problem.

Mrs. Cravello asked about the course being certified. Is the certification good for one year or lifetime?

Ms. O'Brien explained as long as the course doesn't change it would be good for the lifetime of the race. Ms. O'Brien relayed the importance of a course certification. Avid runners will look for shorter runs like a 5K to qualify for a larger run and only certified courses are counted for the qualifiers.

Councilman Kazimir- asked where the profit would be used.

Ms. O'Brien stated that some suggestions have been made on having an electronic sign. In essence, the money would be used to buy something for the school.

Mr. Allos- asked Ms. O'Brien to clarify the use of a separate website for this event instead of the school website.

Ms. O'Brien stated that experienced runners will do a Google search for runs taking place in the area and they may not find it under the school website. Better access, if the event had its own website.

Mrs. Leakas stated that as well as the school website having a link to the event page, maybe the town website could also have a link for this event.

Mrs. Vladyka –Offered support from the PTA.

Mrs. Sanchez volunteered her husband stating they have experience in the field of website construction.

Ms. O'Brien listed a number of faculty, parents & student leaders who are willing to help in all areas. She also stated the Friday before they will have a fun run for the students. Cost would be \$5.00 per student.

Mr. Ammerman stated the next step would be for the Township and Board of Education to approve a resolution in order for this to move forward. This is a great opportunity for the Town and School communities to come together and foster better relationships. Mayor Scarpa- informed the boards that Mr. Ammerman and Mr. Scarpa have been meeting on a regular basis to foster a better relationship. He thanked the Board of Education for hosting this joint meeting and stated the next meeting will be in town hall.

V. Superintendent's Report, Mr. Ammerman reported the following:

- Mr. Ammerman thanked Dr. Sacco, the Midland School Band, Prince Seabrooks
 and the chorus members for their contribution to the Memorial Day service. Mr.
 Ammerman received numerous positive responses to the performance. This has
 been the second year in a row the students have performed at the service.
- One Rochelle Park student- Giovanni Dejesus Padolina is being honored at the Hackensack High School top twenty dinner tonight. Mrs. Cravello is representing the Board of Education at the dinner.
- On May 30, 2013 the district held its first Kindergarten roundup for incoming Kindergarteners for the 2013-2014 school year. The parents were very appreciative, 75% of the incoming parents are brand new to the school. There will be three sections as our enrollment is going up.
- There will be a resolution for a second reading and approval of several policies, bylaws and regulations on the agenda.
- There will be resolutions to reappoint faculty and staff as well as extra-curricular appointments for next year.
- Kindergarten Graduation will be next Thursday June 13, 2013 at 9:30 AM
