IV. Board Retreat- New Jersey School Board Association- Mr. Matthew Lee

1. Board Member Ethics & Governance Training

Mr. Lee handed out two folders, Ethics workshop and Foundations of Board Governance.

The School Ethics Act established the School Ethics Commission, Code of Ethics, Conflicts of Interest, Disclosure Statements regarding both employment and financial interest's, as well as training requirements for Board Members.

The School Ethics Commission consists of nine members, appointed by the governor for 3-year terms, 2 school board members, 2 school administrators and 5 non -school officials. No more than 5 from any one political party.

The governing body has jurisdiction under two areas. Advisory Opinion, where a school official may request an advisory opinion to determine if any proposed activity or conduct by a school official constitutes a violation of the Act and Ethics Complaints which are acts upon complaints filed by anyone alleging a violation of the School ethics Act or Code of Ethics took place.

Each Board members read a portion of the Code of Ethics and answered questions regarding scenarios based on actual cases. Conflicts of Interest were also discussed. Foundations of Governance, outlined the four functions of a Board of Education, which are to provide guidance through policy development. Provide for a program of quality instruction by adopting curriculum standards as academic goals for students to drive achievement. To provide for the effective management of the district by employing and evaluation the chief school officer. Lastly to provide for two-way

communication between the community and the board. The board then took real cases and answered the question "Is this the Board Role".

There was an overview of the eight characteristics of effective school boards, the roles and responsibilities of the board and superintendent.

2. Superintendent Search Proposal

Mr. Lee presented the board with an overview of the different NJSBA Superintendent Search Programs offered by NJSBA and what services are included with each program. The programs range from \$4,000. to \$15,000.00 in cost.

3. Discussion on Board Self Evaluation- Each year the Board is required to do a self-evaluation. The board reviewed the final document.
