F1. 2024-2025 PRELIMINARY BUDGET

BE IT RESOLVED, upon the recommendation of the Superintendent, the Rochelle Park Board of Education approves submission of the preliminary 2024-2025 school district budget to the Executive County Superintendent of Schools, with a total budget of \$16,750,777 with \$_____ to be raised by local tax levy for the General Fund and the following fund expenditures:

11 Fund Current Expense	\$16,089,747
12 Fund Capital Outlay	\$
20 Fund Special Projects	\$ 189,842
40 Fund Debt Service	\$ 471,188

ADDITIONALLY, \$310,984 to be raised by local tax levy for the payment of previously voter approved Debt Service.

And to advertise said tentative budget in the Bergen Record & Our Town Newspapers in accordance with the form required by the State Department of Education and according to law; and
